



X B Cox Jr. led life of military, civic service Rancher and veteran leaves 99-year legacy By: Jerry Lackey Posted: 9:34 PM, Nov 6, 2014 Updated: 1:41 PM, Nov 7, 2014

X B Cox Jr., who died Tuesday three months short of his 100th birthday, left a legacy not only filled with extraordinary military service to the nation, but also of lifelong dedication to the agriculture industry.

Cox earned numerous honors serving in the Army during World War II and had a lasting influence on the San Angelo Stock Show & Rodeo Association, earning its Golden Spur award in 2006 for his decades of involvement.

Kermit Wendland, longtime operations director, worked with Cox at the SASSRA and described Cox as a gentleman and always a professional.

In 2006 Cox, who grew up on a farm in the Ben Ficklin area, told the Standard-Times he couldn't recall missing a single San Angelo Stock Show & Rodeo since 1949. The rancher filled several roles over the decades since, including serving as SASSRA president in the mid-1960s.

"He's one of those fellows who helped lay a foundation we're still benefiting from today," Wendland said. He recalled that when he joined the SASSRA, Cox acted as a mentor, teaching Wendland "priceless bits of wisdom."

He said Cox excelled at advising people on how to work with the public and was service oriented, whether it was with a rodeo contestant, vendor or exhibitor.

"He did it in a caring, professional way, and a compassionate way," Wendland said. "He was a master at that because he cared about people."

John Dublin Jr., a neighbor of Cox's at Royal Estates senior living community the past couple of years, said he met Cox in the 1950s, right after the San Angelo Coliseum was built. Both served on rodeo committees for decades, until a couple of years ago.

"His mind was still sharp at 99 years old," Dublin said. He said Cox would meet with other retired colonels for lunch about once a month so they could reminisce together.

"He's done a lot of wonderful things," Dublin said.

San Angeloan Dudra Butler, who has been friends with the Cox family for about three decades, remembered Cox as someone who "fit the mold of an officer and a gentleman, someone certainly that you looked up to."

She wrote a column in the Standard-Times in February celebrating Cox's 99th birthday. She called him "someone of grand stature, someone who has carried this nation's banner high and well" as he reached "heights achieved by only a few in agriculture, and in the military as well."

Butler wrote that Cox said it seemed unlikely he would make it through World War II alive, but "not wanting to be killed" got him through. "I just couldn't see how anybody could go to war and actually come back — and alive."

She quoted Cox as humbly saying his Golden Spur award "was for longevity more than anything else."

One thing that stood out most about Cox was his love for his wife, Melba.

"They were quite a couple, quite a team," Butler said. "They just worshipped each other. ... They were always together, she looking after him and he looking after her." Cox attended San Angelo schools, including San Angelo Junior College, and entered Texas A&M College in the fall of 1933, graduating in 1937. After graduation he was commissioned a second lieutenant in the Army.

From June 1937 to January 1939, X B was assistant county agent in charge of government farm programs in Coke and Dawson counties. He was Scurry County agricultural agent from 1939 to June 1941.

He was called to active duty in June 1941 and served until March 1946. He was assigned to the 101st Airborne Division when it was established in August 1942 and served in the 81st Airborne AA Battalion. He became commanding officer on March 25, 1945. Cox participated in the Normandy landings on D-Day and fought in Bastogne, Belgium, during the Battle of the Bulge. He also saw action in Germany.

For his service he received the Bronze Star with Oak Leaf Cluster, the EAME Campaign Medal with four Battle Stars and one Bronze Arrowhead, the Occupation Medal, American Defense Service Victory Medal and the Order of Orange-Nassau, Officer Grade with Swords. He was awarded the French Croix de Guerre, the Belgian Croix de Guerre, the Netherlands Orange Lanyard and the Presidential Citation.

Leaving active duty, Cox continued military service in the reserves. He was promoted to colonel in 1956, retiring from the Army in 1967 after 30 years of active and reserve service.

He worked for the wool division of Denver and Boston-based USDA from 1946-49.

Cox and Melba Ruth White were married Nov. 4, 1948. They had two children, X.B. Cox III and Melba Ellen Williams, and four grandchildren and three great-grandsons.

Cox purchased a ranch in Upton County in 1947. When he left his job with the Department of Agriculture he began ranching full-time, raising sheep and cattle. He owned the ranch for 58 years until he sold it in 2005.

Cox was active in many civic affairs groups and projects. He was president of the Businessmen's Bible Class, president of the West Texas A&M Club, was a charter member of the Daniel Wood Chapter of Sons of the American Revolution and was part of the Retired Officers' Association.

He was named the Outstanding Alumni of Angelo State University in 1977. In 2005, he was honored with the Golden Ex by the Alumni Foundation.

Funeral services will be at 10:30 a.m. Saturday at First United Methodist Church, where he became a member in 1927. Burial will follow in Fairmount Cemetery.

X B Cox, Jr., 99, of San Angelo passed away on Tuesday, November 4, 2014. He attended San Angelo schools and attended San Angelo Junior College, on a Massie scholarship, for one year. He entered Texas A&M in the Fall of 1933 and graduated in the Class of 1937. Upon his graduation he was commissioned a 2^{sd} LL in the U.S. Army. Upon his return, following the War, he was appointed to the Massle Foundation Board, on which he served for 32 years. X B was honored as Outstanding Alumni of ASU in 1977 and in 2005 was named Golden Ex by the Alumni Foundation.

From June of 1937 until January of 1939, X B was employed as the Assistant County Agent, in charge of government farm programs in Coke and Dawson Counties. From January of 1939 until June of 1941 he was County Agricultural Agent in Scurry County.

He was called to active duty in June of 1941, as a 1st Lt., and served until March 1946. He was assigned to the 101st Airborne Division in August of 1942; at the time it was established, and served in

the 81st Abn AA Bn. On March 25, 1945 he was promoted to be Commanding Officer of the 81st Abn AA Bn. At 29 years of age. He participated in the Normandy landings on D-Day, rode a glider into Zon, Holland for Operation Market Garden, was surrounded at Bastogne, Belgium during the Battle of the Bulge, and was involved in combat in Germany until the American troops occupied Berchtesgaden, Hitler's Eagle's Nest. From there he was sent to France to prepare troops to go to Japan but because of the dropping of the atomic bomb, he returned to the United States, in November of 1945 with the rank of Lt. Col. He was removed from active duty back to the Reserves, and promoted to Colonel in 1956, retiring from the Army in 1967, after 30 years of active and Reserve service.

During his service to his country he was highly decorated, receiving the Bronze Star with Oak Leaf Cluster, the EAME Campaign Medal with 4 Battle Stars and 1 Bronze Arrowhead, the Occupation Medal, American Defense Service Victory Medal, and The Order of Orange Nassau, Officer Grade with Swords, commissioned by Queen Wilhelmina of the Netherlands. He was awarded the French Croix de Guerre, the Belgian Croix de Guerre, the Netherlands Orange Lanyard and the Presidential Citation. From 1946-1949 X B worked for the Wool Division, of USDA with offices in Derver, Boston, and in San Angelo.

X B married Melba Ruth White in Bryan, Texas on November 4, 1948. He bought a ranch in Upton County in 1947 and ranching became his life after that time. He became a member of First United Methodist Church, in San Angelo, in 1927. X B has been active in many other affiliations, including being President of The Businessmen's Bible Class, President of the West Texas A & M Club, was President 1964-1966 of the San Angelo Stock Show Association, The Retired Officers' Assn., and a charter member of the Daniel Wood Chapter of Sons of the American Revolution, being awarded a 40 year service pin in 2008.

He was active in the San Angelo Stock Show and Rodeo Association for over 35 years. He was awarded The Golden Spur Award for service and dedication on 2006.

X B was preceded in death by his parents, one belowed grandson, X B Cox, IV (Boone), and his brother Donald D Cox. X B is survived by his write, Melba W. Cox of San Angelo, his daughter Melba Ellen Cox Williams and her husband, Herbert E. Williams, Jr., of Kerrville, TX; his son, X B Cox, III, and his write Kelly of Fairfax, Va; his grandchildren, Herbert Eugene "Trey" Williams III and his write Sandy of Wytie, TX, Sarah Elizabeth Junemann and her husband Cory of League City, TX, and Jordan Katherine Cox of Colorado Springs, CO; his great-grandsons Cameron and Mason Williams and Lex Junemann; and one nephew, Donald Boyd Cox, his write Pat and grandniece Kim Denise Cox of San Angelo.

Arlee Claud Gowen, 91, of Lubbock, passed away surrounded by his loving daughter and son-in-law and a host of female admirers in San Antonio on Sunday, October 19, 2014. He was a ladies' man, raconteur of sea stories, dry hole investor, historian, dirt farmer and ballroom dancer that was born in Lamesa to Claud Franklin and Ora Ethel (Cox) Gowen on November 24, 1922.

He attended McCarty community school and Lamesa public schools, graduating from Lamesa High School in May 1939. For two years prior to graduation he was employed by the Lamesa Reporter weekly newspaper at 10 cents an hour on which he worked as a "printer's devil". He also earned money by chopping cotton in the summertime for 20 cents an acre.

In September 1939 he enrolled in Texas Technological College at Lubbock. During his undergraduate days he was employed as a printer at Wood Printing Company and Texas Tech Press. Later he was a sportswriter at the Lubbock Avalanche-Journal. He graduated in June 1943 with a BA Degree in Journalism after serving in the US Navy.

He volunteered into US Naval Aviation as an aviation cadet and prior to reporting for active duty, was employed on the flight line by Breedlove Aerial Service, flight training contractor for the US Army Air Corps. His job was cranking planes on the flight line and was assigned to the USS Randolph (CV-15) as its construction was being completed. In December 1945 Lt.[jg] Gowen received a transfer to Naval Air Transport Service.

On February 1946 he was married to May Belle "Bonnie" Bonner in Crane, Texas. The couple lived at Pantex, Texas near Amarillo Army Air Base where he was stationed. After separation from naval service June 6, 1946 at Galveston, Texas they moved immediately to Lubbock where they had met in college. Arlee assisted in the organizing and founding of Southwestern Crop and Stock, a farm magazine, and was named editor of the publication which printed its first edition in January 1947.

In the early 1950s he assisted in organizing High Plains Credit Corporation and was named executive vice-president of the organization while continuing in the publishing business. In 1959 he established a wholesale electronic supply which became known as Electros, Inc. In 1961 he purchased a farm in Bailey County that he continued to operate until his passing.

In September 1986 he entered a manuscript, "The Widder Dyches" in the Texas Sesquicentennial competition. It was adjudged first place winner and was displayed in the Hall of State at the State Fair of Texas alongside the original Texas Declaration of Independence. In March 1987 he was named to the board of directors of the South Plains Genealogical Society and in the same year was appointed to the board of directors of the Texas State Genealogical Society. In 1987 "The Widder Dyches" received first place in Texas State Genealogical Society competition. In 1988 an account of his fifth-generation grandfather, Matthew Morgan McCall, M.D., Alikchi Chukma of the Choctow again took the TSGS award.
