"Isaac Jackson gives this meeting an account that he spoake to John Cox as desired he that he signified to him that he would send a paper to the next meeting to Condemn his action but he being back in ye woods making a settlement at present so has not done according to expectation.." [This suggests that John was perhaps already off in Newberry Twp at this time. Mary Cox sent her paper to this meeting, so she was probably waiting for John to organized and call for her.] (per Kevin Howley 5/2006)
