Norman Hoyt Cox quietly passed away on February 12, 2013 at the age of 85 in a peaceful end to a long and beautiful life. Norman was born in St. George on February 16, 1927 to Melvin Eugene and Harriet Hoyt Cox where he was raised with his three sisters. He met his life-long love and eternal companion Mary Dawn Barton as a teenager and was married and sealed to her in the St. George Temple on December 12, 1946, recently remarking he was prepared to spend at least another sixty years on Earth with her.

With a few brief exceptions Norman lived his long life in the red desert and sage of Southern Utah where he graduated from Dixie High School in 1946 and was a dedicated and faithful member of The Church of Jesus Christ of Latter-day Saints. Norman proudly served his country in the U.S. Navy during World War II in the Pacific and enjoyed telling his children and grandchildren stories about that time in his life. Following the war he returned to St. George to raise a family of 7 children and to continue the family business - Arrowhead Department Store. Lois Juanita Cox Firmin, a Chillicothe resident died Tuesday, Sept. 4, 2012, at Morningside Center, under the care of the Center and St. Luke's Hospice.

Juanita was born Feb. 15, 1921, in Grundy County, Mo., to Joseph Oscar and Nellie Roberts Cox. Later that year, they moved to Chillicothe, where she spent her entire childhood. She married Joel Firmin in 1948, in Kansas City, Mo. He preceded her in death in 2007.

She was a graduate of Chillicothe High School, attended the University of Denver for one year, and the Chillicothe Business College, graduating in 1941. She then went to Washington, D.C., where she worked for the government during World War II. Later she held secretarial positions in Rochester, N.Y. and Fullerton, Calif.

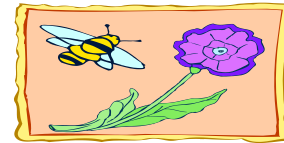
After she and Joel married, the couple resided on a farm near Weston, Mo., and for 20 years they bred and showed Polled Hereford Cattle in cooperation with the University of Missouri Agriculture School, including initiating Performance Testing in Monterey, Mexico and showing the top indexing bull at the University Show and Sale. She was also a Caseworker in Platte County, and held many other positions in the area. They retired and sold their farm and moved to Chillicothe in 1998, to be near family. She was a member of the Grace Episcopal Church, Daughters of the King, Olive Prindle Chapter DAR,

and Grand River Historical Society and Museum. She spent many hours doing family history research for her family and others.

She is survived by seven nieces and nephews, including Betty Lemon and Barbara Cox of Chillicothe. She was preceded in death by her parents; husband; and their only child, David; brothers, Lloyd, Tom, Guy, Claude, Glen, and Clifford; and sisters, Fay Sherrow and Edith Kaufmann

Shenandoah, IA, was born to Clifford C. and Lois Cox on April 26, 1930, outside New Hampton, Missouri. He graduated from New Hampton High School in 1948 and married Deva Whited in 1949. Ed passed away on January 9, 2013, at age 82 years, 8 months, 14 days. Visitation is scheduled for 6:00-8:00 PM Friday, January 11, at Hackett-Livingston Funeral Home in Shenandoah. Funeral services will be 10:00 AM Saturday, January 12, at Hackett-Livingston Funeral Home in Shenandoah, interment at 2:00 PM at Foster Cemetery near New Hampton, MO.

After serving with the Missouri Highway Patrol for eight years, Ed was ordained in the Disciples of Christ Church and served in Rock Port, MO, until 1969. Hello Cox family relatives!

I just wanted to thank you for the November Newsletter, say "hello" from Las Vegas and send greeting and wishes for a Happy Holiday Season. My Cox heritage is Lewis and Anna Campbell Cox - Jedidiah and Rachel Hunt Cox (Hunt and Barney families) -Isaiah and Elizabeth Stout Cox -Jehu and Sara Pyle Cox-Thomas Isaac Cox & Rachel Carr Cox-I noticed in the newsletter the names of Pleasant and Martha Jane Bybee Cox. This is interesting to me because my Mother's (Annie Isabella Campbell) Grandmother was Loraina Bybee. Again the families tie together as they have braided through history. It would be interesting to know the ancestry of Martha Jane Bybee. Here in the Las Vegas area, the Cox and related families was very involved in the building of the town. Two Great Great Grandfathers, Hosea Stout and Edson Barney were first to appear on the scene in the 1850's. Hosea, an explorer and mapper, Edson and 13 year old son went to work in the lead mine at Potosi. Isaiah served as first Bishop in the St. Joseph ward on the Muddy. His plural wife Martha Cragin Cox was the first school teacher in Clark County Nevada. Grandfather Jedidiah worked as a carpenter and teamster for the building of the first train station and other buildings in Las Vegas - he and wife Rachel camped the Big Springs, Old Mormon Fort and Ranch. My Dad worked for the Bureau of Reclamation (B.O.R.) the building of the Dam - from 1927 until Federal relinquished complete control of the Boulder Canyon project around 1965. Also during that time he and my Mom traveled around the states of Nevada, Utah, California and Arizona building roads (Cox Trucking Company) including working at some of the National Parks. He literally built her a house - 8' x 16' on the back of a flatbed trailer and hauled it with the dump truck. That was their home for the first 13 years of their marriage until I came along. Then they settled down in Las

Vegas and built a home on Boston Street. That is now where the Stratosphere Tower is located. There were 10,000 people in Las Vegas then.....and the Mafia Godfathers were just starting the "Strip". A lot of people visit Las Vegas - and for those that are "our Kin" - just want to give you a hearty "Cox family welcome". We are proud of the part we have played in the shaping and building of the west and the Las Vegas area. 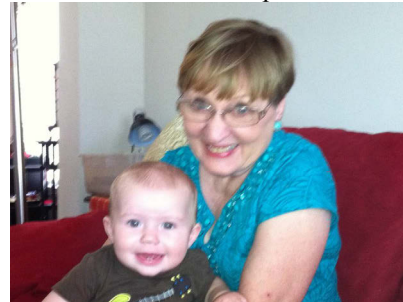

CEMETERY HEADSTONE/MARKER PROJECT

MISSION: To assist in restoring a “flat marker” for those headstones deteriorating over time for future generations, or donate a set amount for labor to install the “flat marker.” Brandywine will contribute up to \$125.00 for each marker

PROCEDURES:

1. Fill out and send in the approved [BRANDYWINE CRUCIBLE HEADSTONE RESTORATION/REPLACEMENT REQUEST FORM](#)
2. Set a standardized size and style “flat marker” and printed information not to exceed three lines or send information for request for labor amount
3. Send photos of the location and of the headstone with request form.
4. Families are responsible for finding a monument company and obtaining an estimate for the restoration and/or labor before making the request.
5. Families will then know if it is feasible to do the work requested for the \$125.00, or decide if they want to contribute to cover any additional cost.
6. Brandywine and the Committee are not responsible for finding a monument company to do the marker repair.
7. Send photos of the completed “flat marker”, or a copy of labor installation.
8. Cox Line relationship: The ancestor should tie into the 4th generation (e.g. Jehu Cox and Sarah Riddle Pyle) or 5th generation, (e.g. Thomas Isaac and Rachel Carr).
9. Frequency: There should be one request per family each year depending on the number of other family submissions.

SEND US FAMILY BIOGRAPHIES AND AUTOBIOGRAPHIES

Brandywine has a long standing project to collect autobiographies and biographies of family members as part of our effort to identify and preserve our family history. All too often, the details of the lives of our family members are lost when they and their immediate descendants pass from this life. Those who settled, developed, protected and preserved this country fade into obscurity. This should not happen, and to avoid it, Brandywine urges family members to write their autobiographies and biographies of their own families. We are interested in parents, grandparents, great grandparents, aunts, uncles, cousins etc, that other family members are unlikely to write about. A concise one-page narrative can capture lots of information, although we do not limit the length. Again, we want to capture the essentials of the life of the individual being written about.. A number of submissions are currently posted on our web site, and you can get some good ideas from those already written.. Please send your narratives to Les Sutton, whose address is elsewhere in this newsletter and is on the web site (lessutton@aol.com). He will include in his files and also submit them to web masters Mark and Katelyn Werner for posting to the Brandywine web site. If you have not participated in this important project, please do so as soon as possible in the interest of preserving our family history. We want participation by members of the entire Brandywine family, by primary line and by marriage.

SEND US YOUR FAMILY STORIES

Separate from, although related to, our biography/autobiography project is the Brandywine project to collect family stories. Numerous members of our old, large, and colorful family have interesting stories to tell. Some may seem very routine and commonplace but relate to everyday life long ago that current and future generations will know very little about unless these stories are recorded. Others may involve very important events or even obscure events in which Brandywine family members played a role. For the same reasons that we want to record biographies and autobiographies, Brandywine wants to record these stories, many of which would otherwise be lost through the passage of time.
