#### A VISIT WITH THE PAST: submitted by Linda Cox Atkins...

Hello Cox Cousins:

September 26 through October 3, 2015. It was a return to yesterday.

Our Family came to settle with William Penn and from there our history began. Brandywine Valley played an important role in the development of the new world colonies.

The log cabin and the Conestoga wagon made it possible to continue to expand west. Native Americans on the Brandywine were the Lenape, meaning the common people. It was a tribe related to them that sold Manhattan Island to the Dutch Governor, Peter Minuit, for a mere \$24.00 in trade goods. The Lenape were eventually made to move west and north. Later they were called the Delaware Indians after the river along which they lived.

The Cox Family were Quakers back in those days, so our little tour group consisting of my granddaughter, Emily Ann Winkler, nineteen years old, fresh out of high school and preparing for college at the time; my husband, Steve Atkins and myself, took the first tour of the week by visiting Kennett Meeting House. We did photos on the historic stepping stone and visited the cemetery.

The on to the Battle of Brandywine, Brandywine River Museum: side note, Philadelphia was off the list of things to do since the Pope was visiting on the weekend we arrived. We visited Longwood Gardens, Hagley Museum, and Winterthur, which was founded by Henry Francis du Pont. It reflects early America and the du Pont family's life there. We traveled to Washington DC and took a whirlwind tour. Just before leaving Delaware, we had a special night out on the town by going to the Candle Light Theatre in Wilmington DE. The people that do the shows are so talented and you get to meet them up close and personal during the performance of Sweeney Todd. Next day, our flight home was great and the bond with my sweet Emily was even greater.

In other words, a good time was had by all.
