



WIKI TREE BY: MARGIE ROMINE

Sharing your Family Story on Wiki Tree.

I recently started using WikiTree as it was a requirement to join a group focused on one of my family lines. I was pleasantly surprised by what a great resource this site is for sharing the stories about your ancestors with others.

It is amazing how organizing your research into a detailed story makes you notice flaws in your story or to gain a deeper understanding of what their lives were like. For example, I now realize that the stories that my mother told me about being in a bomb shelter in Germany during world war two actually occurred during the historic battle of Hamburg where over 42,000 Germans died. Or when I more carefully looked at 1850 census data for my 2nd great grandfather William Thomas Cox, I noticed that he lived next door to members of the same family that I believe now to be that of his first wife. On wiki tree I could explain how I came up with this hypothesis and hope to find someone else that might add sources that support or refute my hypothesis.

I invite everyone that has not already done so to check the site out (https://www.wikitree.com/).

You can find Solomon Cox by searching for him on the site or going directly to https://www.wikitree.com/ wiki/Cox-9671 and then follow the descendent links to read their stories.

You can also choose to join the community (there is no cost) and add details to or sources that support stories that are already there. If you are really ambitious you can add in your own family and link up with Solomon and Naomi.

We will start listing new ancestor pages in the Brandywine newsletter so please let us know if you have created pages for Brandywine descendants.

BIOGRAPHIES AND FAMILY STORIES

BRANDYWINE NEEDS YOUR BIOGRAPHIES

One of our major goals as an organization is to collect and preserve our family history and to inform members of our extended family about that history. One of the ways we do this is to collect your autobiographies and the biographies of your family members that you know as well as or better than anyone else. We certainly are interested in famous or notable family members that you may know about, but interested in every family truly we are member. You have a life's story that no one else has, and that story is important to our extended family. Also, you will have a parent, grandparent, uncle, aunt, etc., whose story you can tell. Some of them, and perhaps you, may have lived through the Great Depression and World War II. Those experiences need to be preserved for our young people today and for future generations. We will publish what we have room for in our newsletter, and we will post all of them on the Brandywine website.

These biographies can be as long or as short as your wish. Tell your story - and your relatives'. Indicate your family line (child of Solomon or Naomi Hussey Cox or an ancestor as far back as you know) to help our family history data base manager and our web master properly index the documents. We hope that all of you will do this.

BRANDYWINE NEEDS YOUR FAMILY STORIES

In keeping with our goal of preserving our family history, we also collect stories. If there is a story that has been passed down through your family, there probably is a substantial amount of truth to it. biographies, it may be unique to vour particular family, and if you don't record it, it may well be lost. It may be humorous, tragic, or in between, or just a family member's involvement in an event that you consider worthy of sharing, but if you are willing to share, we would like to have it. It can be whatever length you want it to be. We are not necessarily looking for scholarly papers, although, of course, we will accept them. But we want to record the family history, and family stories are a big part of that history. We would like to know the source (grandma, Uncle Ed, etc.), but you don't have to footnote or anything like that unless you want You will find examples on our website. We will include at least some, if not all, in our newsletter and post all of them on our website. Identify your family line as far back as you know. We do hope that you will do this.

On February 25, 2021 our Grandfather Jack Thad (born Thadrick Sheldon Cox) Cox posthumously received the **Cross of Military Service Award.** The award was presented the United Daughters of The **Confederacy Chapter Albert** Sidney Johnston 105. The award is presented to veterans of World War II who are lineal blood descendants of a Confederate military personnel. Jack's Confederate ancestor was James Christopher Cox. Jack entered the US Navy on August 30th, 1942 in



the 39th Naval Construction Battalion as a Ship fitter Third Class. The United States Naval Construction Battalions, better known as the Navy Seabees, form the U.S. Naval Construction Force. The Seabee nickname is a heterograph of the first letters "C B" from the words Construction Battalion. Jack was sent to Aiea, Hawaii six months after the attack on Pearl Harbor. Jack assisted in clean up and constructing of new buildings and roads. Jack was Honorable Discharge Nov 28, 1944.

Before and after WWII Jack was in the construction field. Before his death in Feb 1968 Jack was the Building Inspector for the City of Killeen. Jack Cox is buried Killeen, TX. With a Military tombstone.



"Typical Frontiersman Spirit" Sent Joseph Cox From Ohio to Livingston.

The earliest records of Linville have dated back over a century ago, to 1832. Joseph Cox and his wife, Amy, lived in Ray County, coming there from Chillicothe, Ohio. As Mr. Cox was a typical frontiersman, he was unsatisfied with his present home in Ray County, and wanted to move on westward. In the summer of 1832, he and some of his boys started out to look for a new home site.

Some of the oldest residents of this district are descendants of this Cox family. Mrs. Alice Adams, and John C. Cox (who passed away in April of this year, 1937) are children of Abel Cox. Charles Cox and Sterle Cox (twin brothers) are the sons of Isom Cox. All of these have spent practically their entire lives in Linville District and are now past the age of seventy-five years.

Mr. and Mrs. Sterle Cox and family are living at present in this old historic log cabin.

Four generations have lived in this log room; namely, Joseph Cox, Isom Cox, Sterling Cox, Eugenia Cox (Mrs. Everett Anderson).

There are several families that run to the fifth generations that have lived in the district: (1) Joseph Cox, Isom Cox, Sterling Cox, Eugenia Cox Anderson, Reba Jean Anderson. (2) Joseph Cox, Isom Cox, Charles Cox, Maude Cox (Mrs. Lowell Forbis), Russell Forbis. (3) Joseph Cox, Isom Cox, Charles Cox, Frank Cox, Charles Cox.

The first county court was held on the Sterle Cox place, formerly Joseph Cox residence, in a log room that stood just a little north and west of the cabin occupied by the Cox family Sorry to say, it is not standing today. The first court was held there about 1835.

It was also from the suggestion of Joseph Cox that the present City of Chillicothe was named for Chillicothe, Chio. A town from which Joseph Cox had come.

The first teacher in the school was a man by the name of Thomas. He taught for \$1.00 per scholar a month and had twelve scholars.

The first school was taught in 1863.

The present school house is built on up-to-date lines. It has an enrollment of fourteen pupils, ranging in grades from one to eight.

Stanley M. Cox of Kansas City is president of the Cox Family Association. This year relatives from the Texas branch of the Joseph Cox family plan to attend.

The Cox family arrived in Ray County, Missouri about 1818 and settled near Richmond. At that time Livingston County was a part of a greater Ray County, Joseph Cox was the first settler in what is known as Chillicothe township, having moved his family to this part of Ray County in 1833. His original farm located north of Chillicothe is now owned by Manford Cox. Other members of the family settled nearby and on land in Medicine Creek township. Jones Cemetery east of Chillicothe is on land homesteaded by the Soiomon Cox family.

Who Livingston County was established by the Missouri Legislature on January 6, 1837, Joseph Cox was appointed one of the first three county judges; Solomon Cox was one of the first road commissioners, and John Cox was one of the first jury members in the county. From then on, the Cox family has been closely involved with the progress of Livingston County. Though des-

cendants of Joseph Cox now live in states from the Atlantic to Pacific, it is fitting that each year they should return to Livingston County for their reunion.

VINYARD / COX

My name is J. V. Vinyard. I have been doing research on my Vinyard family line since 1993. I have traced my family line back to my 5th G-Grandfather Jacob Vinegard (Vinyard) in Lancaster, Pennsylvania, b. in the 1727/1728 time period and died there in August/September 1757. Lancaster County Orphans Court records show he left three minor children, Philip, John, and Conrad, ages not shown. This John was my 4th G-Grandfather.

No researcher has ever found a clue as to who the father of Jacob Vinyard was until recently. Last year I decided to look closer at three Cox family males I had previously learned I had strong Y-DNA matches with according to FamilyTreeDNA but had never followed up on. I found a number of Cox families in the Lancaster, PA, area during Jacob's time. One Cox I found was an Andra Cox who appears in Lancaster County Court records in August 1728 on the charge of bastardy. This may have been the Andrew Cox, born in Lancaster in 1705, and likely married in January 1730.

Based in this information I have concluded that Jacob Vinyard was born out of wedlock and that his father, my 6th G-Grandfather, was an unknown Cox family member and that my ancestral family name is Cox. If any Cox researcher has any information that might help tie my Vinyard line into the Coxes I would appreciate their help very much.

My John's brother Philip Vinyard has also been well researched. He would also be a Cox. John's brother Conrad was assigned a Guardian by the Lancaster Orphans Court in September 1757 and nothing further has ever been found on him.







Greetings from your latest member of the Cox family project. I am sure you wonder what I am doing here.

I am a 25 year researcher of the Vinyard family which we have traced back to the Lancaster, PA, area around 1720. We feel with a great deal of certainty that our 5th great grandparent was a Jacob Vinegard who died around September 1757 in Lancaster County. He left three minor children, Philip, John, and Conrad. The handling of these 3 children is recorded in the Lancaster County Orphans Court in 1757 and 1758.

Conrad was handled differently than Philip and John by the Court and we lost track of him. However Philip was easily traced as it was not a commonly used name during that period and his brother John was found relating to him through the years until they both died. During their lifetime they used the surname "Vinyard" as we still do to date.

We have never been able to reliably locate the parents of Jacob Vinegard who would be our 6th great grandparents. For while we thought he was of the Vinger/Wenger family who settled in the Lancaster area around 1718. But a DNA test between me and a Wenger family descendant proved we were not related. So we have given up that line of thought.

There was an Elizabeth Vinyard in the Lancaster 1720 and 1724 tax lists. In the 1726 Colonial Records, Minute Book "I" it is stated that a Henry Vinger settle on 200 acres of land in that area but died "some years ago" before it could be surveyed, leaving a wife and two sons. This Henry Vinger likely was the 1717 immigrant Henry Wenger, Sr. No Henry Vinger or Wenger is shown in the 1720 tax listings. And no Widow Vinger or Wenger is shown.

No place in any of our genealogy researching did we ever find the name "Vinyard" as an immigrant in the early 1700s. Long ago I assumed that the name Vinyard was an acquired name. It is my belief that the 1720 and 1724 Elizabeth Vinyard was actually the widow of this 1717 Henry Vinger/Wenger.

Also included in the Lancaster County 1724 and 1725 tax rolls was an Andrew Cox, a single man. I know very little about this Andrew. I mention him to show there was a documented Cox family member in Lancaster during this period. Maybe there were more Cox people there at that time that we don't know about. Cox researchers have listed an Andrew Cox born in PA in 1705. I have no idea if both these known Andrews were the same person.

My DNA has been posted with FamilytreeDNA since 2006. During the years since a number of related matches were listed for me that I did not specially note. I was only looking for Vinyards. But recently I decided to look closer at these other matches. Three of them were Cox family members. When I checked them all more closely I found the probabilities that we had a common ancestor 8 generations ago was 89.08%. I am a 9th generation Vinyard. Eight generations back for me would be in the early 1700s in the Lancaster area.

So – we have the Widow Elizabeth Vinyard and an Andrew Cox in the same area around 1724/25, the period I figure my 5th great grandfather Jacob Vinegard was born. The widow Elizabeth Wenger/Vinyard had two sons, John and Henry, who are accounted for. It looks like Jacob Vinegard (Vinyard) who was born well after Elizabeth Vinyard became a widow. So what is the likely connections here? I don't have the answer, for sure. I do think that if my DNA is of the Cox line then it occurred in one way or to other during this period.

So I have joined the Cox family project to see if I can some help on solving the problem of who is my 6th great grandfather. I welcome your assistance.

One last thought that might help. I am a member of the U152 Sub Clade project. FamilytreeDNA researchers have determined that members of this project are descended from the ancient Celtic clan. It the Cox DNA shows they are also in the U152 Sub Clade then it would strengthen the likelihood we are related.

I am still wrestling with Andrew and Andra Cox. Andrew was born in PA in 1705. Andra was in Chester County Court in August 1728 concerning an unborn child. At first I figured this unborn child could not have eventually been my 5th G-Grandfather. By now, by a tight fit, maybe he could have been if the child was a male. The Court decision, likely, to name the child by some surname I cannot read, could have been overridden in later years to another surname.

I am still looking at Andrew and Andra Cox as being the same person and he could be the guy I am looking for.

But I can find nothing about the parents of Andrew. I need some help here. It would be helpful, one way or the other, if I could find his parents. I may have a clue here. The Quaker Meeting Records for Lancaster in 1728 provide the following information: Deceased, Samuel Cox, 6/21/1728, William Cox 10/26/1728, and Thomas Cox, 12/2/1728. No ages mentioned. Parents of all listed as Thomas and Martha Cox. This shows other Coxes in the Lancaster area at the time of the birth of my G-Grandfather. Maybe this is Andrew Cox's family.

In March 2015 I contacted a William Arthur Cox in Austin, TX by e-mail. He was a match provided to me by FamilytreeDNA. He advised he had Cox family members living in the Lancaster area during the time period we are looking at. His ancestors there were Thomas Cox and wife Elizabeth Fincher. I did not follow up this contact as I was still thinking 100% about finding Vinyard family members at the time.

Apparently my Cox connection came from within these Cox families in some way.

Would love all the help I can get on my Cox research.

I recently contacted — and provided her my DNA Kit number 57646. My DNA report has been listed with Familytree DNA since 2006. Familytree DNA advised me I had DNA matches with a John Albert Cox, a William Arthur Cox, and a Ricky Dean Cox. Ricky Dean Cox listed his oldest known ancestor as a Thomas Cox, born 1641. — advised Terry Barwin and I that my DNA matched the Cox line and she placed me in the Brandywine Cox group. I have since been in contact with Terry and Joe. They gave me your e-mail address.

This connection between the Vinyards and Coxes is a recent, and unexpected, development. I am anxious to follow up on this finding and see where it takes us. I have genealogy research on the Vinyards that goes back 300 years to Lancaster, Pennsylvania, where an Andrew Cox is listed in the 1724 and 1725 Conestoga (Lancaster area) district tax assessment list as a single person. A good place to start.

Of interest. My wife has a nephew who lives in Lufkin. He was raised in Louisiana. He considers going the Shrimp Boat Manny's to eat as a treat.









